## Critical importance of quality early care and education

- Statewide need for equitable access to quality early childhood services
- Importance to the healthy development of our children and families
- Importance to the current and future economic vitality of our communities, our state, and our nation

#### A dynamic plan by and for Nebraskans that seeks to ensure that all children have access to quality early childhood services

- Informed by comprehensive statewide needs assessment
- Addresses priorities identified by stakeholders in communities across the state
- Focuses on results and measuring systems change
- Integrates needs assessment, strategic planning, and performance evaluation for sustainable change in Nebraska's early childhood system

## Shared vision

To provide all Nebraska children and their families with access to quality early childhood services that support children's healthy development from birth through age 8.







#### Four interrelated goals

- Goal 1: Access
- Goal 2: Quality
- Goal 3: Collaboration
- Goal 4: Alignment

Work on any one of the goals will impact and inform the other goals.

#### Goal 1: Access

Each child and their family can access the quality early childhood care, education, and essential services they need to support each child's healthy development.

- Focuses on equitably serving each child and family in the state—no matter where they live or what challenges they face
- Strategies to increase the availability of quality early childhood services and to improve families' ability to access the care they desire for their child

### Goal 2: Quality

All early care and education settings provide quality experiences for children.

- Defines quality in terms of each child's experience, emphasizing the importance of positive and consistent interactions between the child and caring adults—no matter the setting
- Focuses on achieving a shared understanding of what quality means in early care and education and infusing that definition into every aspect of the state's early childhood system

#### **Goal 3: Collaboration**

Communities coordinate a locally designed mixed delivery system that provides continuous care and meets the needs of families.

- Focuses on facilitating collaboration among community leaders to identify strengths and priorities and develop local plans to improve access to quality care
- Emphasizes building new collaborative relationships among providers
- Builds on existing partnerships to facilitate greater coordination of resources and services

#### Goal 4: Alignment

Statewide systems align to support communities in creating an integrated and comprehensive mixed delivery system for all children.

- Focuses on creating a more integrated early childhood system that provides seamless access to services
- Aligns statewide systems to facilitate delivery of quality services
- Develops capacity in the state's data systems to support data-informed decision making
- Builds capacity for efficient governance and ongoing improvement in Nebraska's early childhood system
